"Today's investors are looking for access to solid alternative investments to hedge against the stock market's volatility. Additionally, they want to know the story behind who they are investing with and to take part in that story, while also ensuring that the values of the group managing their investments align with their own values. We view this as a long-term strategy to build up meaningful relationships with investors who want to join us on this journey, while passively investing in one of the most sought-after asset classes that exists."
